## Summary of culture and its different practices

#### The Cause for Lack of Cross Cultural Understandings:

Being that there are different cultures all over the world, there's going to be a lack of cultural understanding from one culture to another. Misinterpretation is one reason why there may be an issue in understanding cross cultures. Miscommunications between two members of

different cultures creates misunderstandings which ultimately leads to misinterpretations. Another reason for the lack of cross cultural understandings is ethnocentrism. The term "ethnocentrism" can be defined as judging or evaluating other cultures based on one's standard and own culture customs. This concept can lead to cultural conflicts. According to Dini Amanda's "Cultural Conflict", "In cross-cultural interaction, speakers sometimes assume that what they believe is right, because they have grown up thinking their way is the best. This ethnocentric assumption can result in negative judgments about other cultures" (Amanda, 2015). Which furthermore makes it difficult for cultures to mutually understand each other's cultures. Cultural differences also play a major role in the lack of cross cultural understandings. There may be cases where one culture goes against the beliefs and values of their culture. Hence, they disagree with that culture making it hard to adapt. According to Businesstopias "Cultural Barriers to Communication", cultural diversity is also a reason why it's difficult for a certain culture to adapt to another cultures social interactions. They state, "Cultural diversity makes communication difficult as the mindset of people of different cultures are different, the language, signs and symbols are also different" (Businesstopia, 2018). So this indicates the different cultures have different meanings of words, ideas, behaviors and gestures. Furthermore, creating barriers in communication within two different cultures. So there are some examples of why there exists the problem of lack of cross cultural understanding.

#### Overall or General Societal Problems of Lack of Cross Cultural Understanding

Lack of cross cultural understanding can lead to many problems in the society and in general. It can lead to lack of trust between racial groups and different cultures. Not understanding their perspectives and values of the world from different cultures can also lead to

ignorance. In which, ignorance triggers the idea of prejudice towards other cultures. A culture makes biased and unfavorable judgments and evaluation of other cultures. The lack of cross cultural understanding can also make some people uncomfortable and less desirable for embracing their cultural backgrounds. So the problems of lack of cross cultural understanding stirs up societal problems as well as problems with one's identity and relations with their culture.

#### Personal Encounters or Experience With the lack of Cross Cultural Understandings

It was a rough time moving to America for the first time. No knowledge of the english language and the American culture and its norms and values made it tough personally. It didn't help that the American culture was totally different from the Tibtetan culture. They did have its few shares of similarities in norms and values but, mostly everything was different. One of the main differences between the two cultures were its greetings. In Tibet, the greetings are more formal as there are certain gestures that have to be done. Such as placing two hands together and bowing down a little bit and saying "Tashi Delek". However in America, people greet each other more casually. They usually just say "Hey, Wassup" and just greet by giving a handshake or sometimes a hug. When seeing people in America greet for the first time made me think of the American people as a bit rude and too casual with others. Same thought came when witnessing Americans address each other casually by their names. In Tibet, people address everyone by their seniority. For instance, when someone is older, they should be addressed as "Acha", big sister, or "Chocho", big brother. When someone is a senior or an elder, they are addressed as "Popo", grandpa, "Appa", father or "Momo", grandma, "Amma", mother. They are all addressed formally regardless if they are a part of the family or not. Tibetan culture is very strict and formal when it comes to greetings and addressing other people. So this created the thought that

Americans were not respectful and rude. They don't formally greet their elders nor do they address their elders in formal ways.

## **Overcoming of this Cultural Divide**

Despite having questionable and unfavorable thoughts about the American culture, there was no other option but to try to adapt to the American culture. Some ways that helped with adapting to the American culture was by learning from others, eliminating assumptions and just experiencing the American culture. When it came to learning from others, people taught and exposed the history of American culture. As well as why some American norms and cultures exist. Due to that, my knowledge and understanding of the American culture expanded little by little. Eliminating assumptions about the culture played a major role in overcoming this cultural divide. The assumptions that Americans were disrespectful and a bit rude had to perish. Less assumptions and treating everyone the same really helped. Not only did it help me become more open minded but it also helped with becoming more aware and understanding of the American culture. Lastly, experiencing the American culture strongly helped with overcoming the cultural divide. Going to parades, celebrating American holidays like christmas, halloween and 4th of July, trying out American foods, listening to American music, using American slangs all contributed to the understanding and adaptation of the American culture personally.

#### White Privilege

The lack of understanding another culture or racial groups leads to one group feeling more superior than other groups. In the case of America, the majority group that is more superior than the other racial groups are the whites. This point is proven by people in the racial group of

Whites having more privileges than other racial groups. According to Ashley Needham, an antiracist White person, she emphaizes the idea that is easier to be White in America than any other racial groups. She mentions several examples of the privileges White Americans have. White people don't have to worry about getting shot while handing police officers their license. In job interviews, they know that their intelligence nor their integrity is questioned because of the color of their skin (Needham, 2016). It is also said that these privileges are not earned but rather given to them upon birth. So based on that, it is easier to be White in America than any other racial groups.

## Sterotypes, Discrimination and Racism Towards African Americans

Unlike Whites, Black or African Americans face the most difficulties living in the United States. Not only do they have to deal with stereotypes about their race but, they also have to go through experiencing discrimination, injustice and racism. This the doings of the lack of cross cultural understanding. Ignoring the idea that everyone is equal and continuing to support the idea that Whites are more superior causes problems for blacks and other minority groups. When it comes to stereotypes towards African Americans, it's usually negative stereotypes. Black mens are stereotyped as threatening, hostile, aggressive and are associated with guns (Hester, Gray, & Richeson, 2018). An instance of someone getting killed due to these stereotypes was Eric Garner. At the time he was being put under arrest, police officers saw him as threatening and feared his "Black rage" as he was 6'3 and 350lb (Coleman jr, 2019). Due to his presence of being tall, dark and threatening, the police officers subdued him into a chokehold that resulted in his death. Along with negative stereotypes against black people, they also face the oppression of systemic racism. These systemic racism are the reason why there is a movement called "Black

Lives Matter". For so long African Americans have been going through the hardships of police brutality, oppression and systemic racism. These actions have led to African Americans getting wrongfully killed. Some names of those who were wrongfully convicted and murdered by officers are Eric Garner, Breonna Taylor, George Floyd, Ezell Ford and many more (CodeSwitch, 2020). When looking at each person's final moments before being killed by police officers, none of them were committing any crimes or doing anything wrong. But because of their skin color and misjudgment and the idea of systemic racism, police officers killed them. So due to these horrific actions, people have created the movement of "Black Lives Matter". This movement's goal is to raise awareness on violence inflicted on black communities, protest against those violence and police brutality and bring justice and racial equality for Black people (Schumer, 2020).

## **Racism Towards Latinos and hispanics**

The lack of cross cultural understandings also creates racism towards Hispanics and Latinos. Watching the news and reading reports, there have been multiple incidents of hate crimes against Latinos. Noting that some of them are immigrants, Latinos go through racial epithets, death threats, assualts, robberies, and even murder. The worst part about these situations is that Latinos are fearful of reporting these hate crimes to law enforcement. Some are fearful of the perceived climate of anti-immigrant animosity encouraged by president Trump, and those who are undocumented are fearful of being deported (Mendoza, 2018). In situations where they may get deported, they are first sent to ICE or the immigration detention center. This center is where they hold immigrants while awaiting a determination of their immigration status or potential deportation. However the condition in the detention center is very inhumane and rough.

Adults and childrens are cramped in there, no access to sanitized water, subjected to cold temperatures and overall poor conditions (Joung, 2019). It is also mentioned there have been multiple deaths regarding childrens, some are very sick and others are hospitalized. So these issues of ICE and its detention center and Latinos getting deported is because of the inequality and racism towards Latinos in America. Latinos have come to America for a better life but yet they are getting mistreated. They work hard like any other people and deserve equality and they deserve to be here.

#### **Racism Towards Asian Americans**

Ever since Covid-19 arrived, it is not only to my observation but it is very clear that hate crimes and racist remarks against Asians have skyrocketed. Instead of understanding the whole situation with the virus, people see that it started in China and now assume every Asians carry the virus. With this ignorance and lack of cross cultural understandings towards asians, it is only bringing more hardships and backlash towards Asians living in the world. There have been reports of over 100 hate crimes per day against Asian Americans. As well as reports of racial slurs, physical violence, workplace termination, spat on, extreme distancing, etc (Croucher, Nguyen, Rahmani, 2020). Media and government officials have also stigmatized and blamed "Asians" for the spread of Covid-19, in which resulted in increased hatred towards Asians. President Trump has addressed the coronavirus as the "Chinese virus" on many occasions. Even though public health experts and the World Health Organization (WHO) have told him not to address it as "Chinese virus", because it is inaccurate, inappropriate and dangerous for Asian Americans. President Trump has continued to refer to the virus as "Chinese Virus" (Clausen, 2020). This ultimately led to increased prejudice and hate towards Asians. Covid-19 has also

shut down many Asian businesses. With many beliefs that these Asian restaurants have the virus or carry the virus, people are scared to eat there. Some go out their way to vandalize asian businesses. With the blame on Asians for bringing the virus, people want to get back at them by destroying their businesses (Walker, 2020).

#### **Multicultural Education**

In a country that's becoming more and more multicultural, the United States has to continue implementing multicultural education in every school. It is stated on the *Digest of Education:2018*, "50.7 million students attended public elementary and secondary schools in 2018, bringing a variety of backgrounds, languages, perspectives, and cultures to the classroom. Since culture and education have an impact on each other, it is important for people of all cultures to value education and for the education system to value all cultures" (NCES). So it's important to implement a multicultural education due to the fact that it helps all students from different cultures to value education. When it comes to defining multicultural education, it is best described as, "what schools implement to establish equitable educational opportunities for all their students. It is also an ongoing process of helping students succeed in their academic and personal lives." (AUSOE,2020).
