Duffy (1999) states that in the 90s, there was no specific law to protect homosexualsfrom prejudice. He goes on to mention that even the civil workers such as fire fighters were forced to keep quiet about their sexuality at that time. According to LGBT Finance (2012), "themodern gay rights movement only began in the late 1960s and has developed into today's relatively broad acceptance in the UK and parts of Europe." BBC Newsbeat (2014) states that there is a more open and fluid approach to sexuality nowadays. For example, the decriminalization of homosexuality in1967 and the introduction of civil partnerships in the newmillennium. It is now illegal to discriminate against others based on their sexuality under the Equality Act 2006. According to LGBT (2012), a complaint was made to the local police in Cambridge shire regarding a gay couple who was turned away from staying at a local B&B andthe gay couple managed to sue the B&B owners for turning them away.
